Symbiosis Law School, Pune offers one-year part time '**Diploma in International Business Laws and Corporate Laws in India**' (D.I.B.L. & C.L.I.) with an objective to impart legal knowledge in relation to international relations and business transactions. It also emphasizes on the role of Indian Industry and the legal system in global legal order.

It includes five main modules, as follows:

1.	International Economic Law, Overview of Corporate Taxation and Laws Relating to Banking
2.	Company Law: Practice and Procedure and Indian Financial Market and SEBI
3.	Competition Act, Consumer Protection Act, Arbitration and International Commercial Arbitration
4.	Skill Building - Compulsory Moots, Drafting, Journals, Field Visits, Projects and Viva
5.	Project

Registration Procedure:

A candidate interested to register for D.I.B.L & C.L.I. has to follow following steps:

1. Visit www.symlaw.ac.in and read and understand the procedure for registration other eligibility related requirements.
2. Must complete registration procedure by filling online registration form and paying Rs. 1500/- towards registration fees.
3. On successful registration, academic fees need to be paid as per the schedule provided below. (Offer letter with payment details will be provided on registered email Id on successful registration.)

Please note that admission is confirmed only on the payment of academic fees and meeting the eligibility criteria as prescribed by the Symbiosis International University, Pune.

Kindly note that it is mandatory to attend classes and skill building exercises in person.

Eligibility Criteria:

- A candidate should have cleared 10+2 from any recognized Board; and
- A candidate who is pursuing a law programme in any college, or
- Graduates from any recognized University.

Documents Required for Admission:

All below mentioned self-attested documents are required in 2 copies:

- Offer Letter
- Aadhar card as ID proof.
- Colour photographs.
- For students pursuing law degree, 12th Mark sheet and 12th Passing certificate; a bonafide certificate for academic year 2026 – 2027 from their respective college
- For graduates, Statement of marks of all semesters/years of graduation and Passing certificate/degree certificate of graduation (any 1 document)
- For students of Symbiosis Law School, Pune the fee payment receipt or identity card of the Symbiosis Law School, Pune is required.

Mode of Payment:

A candidate shall make following payments for confirming admission:

1. Rs. 1500/- towards diploma registration fees by using Credit Card, Debit Card, Internet Banking provided on the Diploma Registration Form.
2. Academic Fees, as given below, can be paid in two instalments via the link provided in the “offer letter” by using Credit Card, Debit Card and Internet Banking or Demand Draft.

The “Offer letter” will be sent to registered email ID after filling up the registration form and payment towards Diploma Registration Fee.
