EDITORIAL

G20 Summit and Education: India's Pitch for Sustainable Development Goals.

"The global challenges call for a global response. We need a strong partnership that brings together all major economic powers, so that we do not further exceed the limits of our planet." - Barbara Hendricks

The preceding G20 presidencies have brought about significant developments - from economic stability to taxations, they have touched upon various key aspects concerning member countries. As the world grapples with the aftermath of the COVID-19 pandemic, the provision of quality education has become a paramount issue, serving as a cornerstone for the long-term prosperity and well-being of nations and communities.

According to the Indian cultural understanding, all objects are considered derivatives of the 5 tatavas earth, air, water, fire, space- and the harmony of these is our theme 'One Earth, One Family, One Future.' In furtherance of the theme, the National Education Policy (NEP) 2020 serves as India's guiding light in realizing G20's shared goal. It is an ideological document that is built on the core values of accessibility, fairness, excellence, affordability, and accountability. The spirit of NEP 2020 that is to be cascaded in events includes discussions, and insights with four key themes: ensuring literacy and numeracy, the role of technology in education, the future of work and capacity building for lifelong learning, and strengthening research collaborations. In addition, India is a participant in the United Nations Sustainable Development Goals (SDGs), including SDG 4 on education, which aim to provide quality and equitable education and promote lifelong learning opportunities for all. India has preached sustainability and inclusivity dating back to its Five-year plans and even the Union Budget of 2022, which included the humanitarian-development plan, 'India's Amritkaal'. Apart from the enforcement of the NEP, the nation has strived to undertake various measures to showcase its compliance with the widely followed Sustainable Development Goals.

Firstly, India has pitched in to alleviate the vaccine crisis via the Vaccine Maitri programme. The 6th Intergovernmental Panel on Climate Change (IPCC) assessment report elucidates upon the adverse climatic changes set to happen along the Indian coastline, which will destroy millions of lives and lifestyles. Cognizance of this means expanding on pre-existing ideas like the Indian-led initiatives such as the International Solar Alliance (ISA) and the Coalition for Disaster Resilient

It was delivered by the Chief Guest, Prof. (Dr.) Yogesh Pratap Singh, Vice-Chancellor, National Law University, Tripura. The theme of Constitutional Law Day was "India: The Mother of Democracy" and the topic of the lecture was "Transformative Constitutionalism: Indian Experience". Prof. Dr. Dhanaji Jadhav, Associate Professor and Deputy Director (Administration), Symbiosis Law School, Pune, delivered the welcome address by reflecting on the importance of commitment towards the Constitution and respect towards constitution makers. Prof. (Dr.) Yogesh Pratap Singh then addressed the audience and emphasized how the exercise of fundamental rights and duties is essential for the ideology of constitutionalism to flourish. He acknowledged how Justices D. Y. Chandrachud and U. U. Lalit recognized the excellence of the constituent assembly members in drafting a constitution allowing the implementation of reservations to remove deep-rooted

structural inequalities, thus progressively transforming society. Exemplifying the K. S. Puttaswamy and Shayra Bano cases, Prof. Singh focused on paragraph 99 of the Navtej Singh Johar case, which describes the Constitution as a transformative tool whose purpose is to ensure the dignity, freedom, and equality of the downtrodden section achieved through the realization of their fundamental socio-economic rights. He concluded by applauding the conviction of the institutions in bringing about massive progress, questioning their own beliefs, and moving beyond any subjugations.

Workshops and Guest Lectures conducted by Judge Tiffany Williams Brewer

The International Cell of Symbiosis Law School, Pune hosted a series of guest lectures by Judge Tiffany M. Williams, Associate Director for Advocacy, Empowerment and Faith, Administrative Law Judge (Ret.), Assistant Professor at Howard University School of Law, Washington, D.C. on Introduction to Legal Skills (Advocacy) from 29th November, 2022 to 17th December, 2022. Justice Williams began with a brief revision of the skills a lawyer must possess. Justice Williams then delved into the various kinds of legal writing, the first being preventive, where she explained that the clients or senior attorneys are the audiences, helping clients devise creative strategies to achieve their goals. The second is predictive, where the likelihood of winning the case, being able to sue them and recover damages from them and the extent of the client's liability are discussed, and the third is persuasive, where judges are the primary audience, advocating their client's side.

Justice Williams explained the need to be well-versed with the client's issues and needs to the students. The various methods to achieve the same are issue-spotting, regular client meetings, and thorough research of the law. Further, Justice Williams took up the kinds of writings a lawyer must do in their career. She emphasized that client advice letters, memos, and statements should be well-organized, precise, concise, simple, clear, forceful, organized, and

eloquent as are the standards of legal writing. She also explained the format of a client advisory letter to aid the students.

It was held on 30th November 2022. The revered speaker for the guest lecture was an eminent economist and Professor Dr. Chandrashekhar Govind Ranade, Member of India Agriculture Group, Washington, D. C. and Professor at Stanford University.

The guest lecture began with an introduction of the speaker by Mr. Bhupesh Chintamani, Assistant Professor, SLS, Pune. Dr. Chandrashekhar Govind Ranade began his lecture with a narration of his experiences prior to the announcement of lockdown in the United States. He then related inflation with the COVID-19 pandemic and highlighted that the deficient supply of commodities leads to rise in prices. He further talked about the Ukraine War and its effects on the rest of the world. He explained how the prices of edible oil rose in India due to the insufficient supply from Ukraine, a major exporter of edible oils. In light of this crisis, he stated that globalization could solve this problem. However, China plays a central role in globalization and is currently facing its own troubles. This was followed by a question-and-answer session wherein the students and faculty members raised riveting questions.

ROTARACT CLUB




LAW ECON CELL






