The ceremony began with the watering of the Bilva Sapling by the dignitaries on the dais, namely, Prof. (Dr.) Shashikala Gurpur, Fulbright Scholar, Director, Symbiosis Law School, Pune, Dean, Faculty of Law, Symbiosis International (Deemed University), Jean Monnet Chair Professor (EUC-LAMP Co-funded by EU); Dr. Rama Joga Rao, Additional Legal Advisor, Department of Legal Affairs, Ministry of Law & Justice, Government of India; Retd. Prof. (**Dr.**) Shashikala Gurpur extended a gracious welcome address setting the tone for the proceedings with great poise. Eloquently, she highlighted the genesis of SICTA and the strong brand value it holds as an inter-collegiate competition. She highlighted the contributions of alumni who have been instrumental for the tremendous success of the competition. She outlined the vision of **Dr. S.B. Majumdar, Chancellor, Symbiosis International University**, in making the institution a pioneer in legal education. She also emphasized the growth of SICTA as

a competition that resonates with the ICC criminal proceedings and that its stature is highly commendable not just in terms of the competition, but also the hospitality. He concluded his remarks by sharing personal insights in relation to the city of Pune and his inspirations in life.

The Guest of Honour, Dr. Rama Joga Rao Additional Legal Advisor, Department of Legal Affairs Ministry of Law & Justice, Government of India, in the keynote address, contextualized the situation of today by explaining that how globalization has reduced the mass trade barriers massively. Consequently, he stressed on the crucial role of lawyers in the era of technological advancement. He emphasized the significance of competence by quoting Saint Kabir. He reiterated that the trial advocacy competition is a useful instrument, especially, in the metamorphosing legal arena. He wrapped up by delving into the intricacies of criminal trial, notably, the process of cross-examining the witness.


