The journey of a thousand miles begins with a single step. But it involves deliberation and much hesitation. The Symbiosis journey however began with a surge of enthusiasm spurred on by an incident that, in itself, makes a poignant tale. It is an inspiring tale and in the words of the founder of Symbiosis, Dr. S. B. Mujumdar, it says:

"It was afternoon on a hot day. I was standing near a window of my house overlooking the first hostel block, of which I was a rector. A strange thing happened. A girl walked up to the window of the boy's hostel room, quickly handed over something and disappeared. My curiosity was aroused and I kept watching the girl walking up to the window day after day and suspected, like any other rector would, that an affair was afoot.

So one day, I made up my mind and walked up to the door and knocked. When the door opened, I saw a Mauritian student lying in bed. His face was pale and his eyes seemed to have sunken low.

I was puzzled!!

When I turned to the boy for an explanation, he said, "Sir, I have an attack of jaundice and I'm feeling extremely weak. I cannot stand up, nor walk a few steps. A girl from my country brings me food. However, since ladies are not allowed to enter the boy's hostel, she hands over the lunch box through the window."



I was stunned, after all, it wasn't the type of 'affair' I had expected. I was very much pained and decided something had to be done about this. That was the instance! A golden moment! "Symbiosis was born".

Symbiosis is a term in life science, meaning 'living together of two different organisms for the benefit of each other. Dr. S.B. Mujumdar, himself a professor of botany, thought this name apt for the institution.

Thus, the institution was founded to alleviate the problems faced by foreign students coming to India. At the time, these problems included- accommodation, meals, medical care, guidance, coaching, information about the city etc.

Symbiosis has come a long way since then. Today it is a home to students from more than 85 different countries. These students are offered the best learning resources, industry, exposure, a strong International Students' Alumni network, a global recognition and above all, a truly enriching India experience. The colossal Symbiosis Law School, Pune was established in 1977 by ace

Dr. S B Mujumdar. Earlier the School was affiliated to the University of Pune, and later it became an integral part of Symbiosis International University in 2002. It upgraded the excellence in terms of teaching, learning and research. By 1985, it was the first college to offer five year **integrated LLB** program, the **BBA LLB** program. It was one of the first three constituents when Symbiosis was conferred the deemed university status by MHRD, in 2002. Today, the exemplary law school has been ranked among the top three law schools out of twelve hundredin India.

Symbiosis Law school Pune also offers one year LLM course with sevenspecializations. The superlative University is standing in the front linedue to its excelling ignitors such as cutting edge curriculum, comprehensive student development programs, strong internationalization with a strong emphasis on Research. The school is an abode of eighteen hundred students across integrated BA/BBA LLB Honors programs, three year LLB and one year LLM, competent faculty, ICT-driven rich learning resources and an ecosystem of excellence.

Henceforth, the output of the school has kindled the chandeliers of success and superlative results by giving four high court judges, scores of district judges and magistrates, senior leadership positions in top law firms, civil services and corporate apart from academic leadership.

Community Legal Service Program of the law school won the **'Herbert Smith free hills'** award, and the Law School's leadership is engaged with national and international quality legal educational initiatives, which link all stakeholders.



TEACHING METHODOLOGY

CLASSROOM

The faculty of SLS, Pune conducts lectures on an hourly basis with the students which constitute a major portion of the teaching. The Teaching plan and its execution is designed and executed in such a manner that it encourages students to participate in discussions and maximise class participations in order to make the sessions more interactive. Further teaching aids such as projectors, microphones, speakers and PCs, employed in all classrooms make the teaching process simpler and better.

GUEST LECTURES AND SEMINARS

In order to provide our students a better understanding over a particular topic and a holistic view of the legal application of concepts, various guest lectures with prominent national and international intellectuals are also organised very frequently as a routine teaching process. We at SLS, Pune encourage our students to take part in the seminars and Co-Curricular activities and often organise them at our campus as well. This not only gives a better insight into the topic, but also helps to improve the speaking and learning capacities of the students.

INTERNSHIPS

We believe that classrooms can never teach everything to the student in a profession like law where one keeps learning throughout his life. We prefer that field knowledge is an integral part of the learning process. Hence, we encourage our students to take up more internships in order to gain more experience in their respective fields. Furthermore, a minimum of five internships each of not less than four weeks is necessary for graduation.





EXCHANGE PROGRAM

Our Exchange Programme is in collaboration with DAAD and includes several universities in Japan, Australia, Germany, Ireland, etc. It is a very unique feature of SLS, Pune as it helps not only in the exchange of ideas but also in different cultures, thoughts and mindsets, hence broadening the scope of our students' avenues, providing a sense of universal togetherness. It also furthers the student's education in international aspects of law.

RESEARCH

Symbiosis Law School. Pune encourages research writing to a great extent. We organise special lectures to teach students proper research methodology. Following the Harvard Bluebook format of writing we make our students habitual to research writing by giving them routine research work as part of their internal assessments. Many students also succeed in getting their papers published in journals of nationals and international repute. Students receive constant faculty guidance for the same.

MOOT COURTS AND MOCK TRIALS

Moot Courts and mock trials are one such practice in clinical legal education which plans students for lawyering in such a way to the point that the apprenticeship is minimised and frequently separated with. They are conducted regularly and count as a vital part of internal evaluation. Students are also encouraged to participate in as many external competitions as possible to help their growth further. Students who represent the college in the national and international mooting circuit are trained and assisted by not only the SBA members, but also by experts in various fields of law. The students are also equipped with resources like books, researching aids and legal journals which help them expand their knowledge base for the same.

MENTORING

Mentoring system is acquainted to create inspiration and execution amongst the understudies, which is a key to individual and hierarchical achievement. Every faculty member mentors nearly 10 students from each batch. The mentoring system includes gathering with mentees, dialogues with regard to the schedule, study designs, exercises inside and outside school, different issues confronted by them inside the law school system and companions, understanding their versatility to the local culture, learning process, participation and execution in the examinations.

The Campus is facilitated with 24/7 internet connectivity through a high-speed Wi-Fi network with Research databases running on all servers. Each classroom is provided with state of the art technology to simplify the teaching process. Furthermore, there are two information and Communication Technology labs for the students. At SLS, Pune we believe that learning is never limited to the classroom, and hence we provide our students with special areas like the Reading Hall and Mooter's Zones to study and prepare for their various events. One of the most important parts of SLS, Pune is its library having more than 1,00,000 books along with its online Research Databases, facilitating its students' direct access to a wide range of topics.



RECREATION

Symbiosis Law School, Pune also emphasises on recreation and all round development of students. We have a well-equipped gym, open for all students of SIU. The cafeteria, present on the ground floor, provides a wide range of delicacies to the students. A multi-purpose hall, with a capacity of 600 people, is used to conduct various cultural and routine functions. Furthermore, Common Rooms are provided, equipped with indoor games like chess, carom, table tennis, etc.

FACILITIES

For the convenience of students and staff, an ATM has been provided in the campus. The campus is under 24/7 surveillance through CCTV cameras. Furthermore, there are public lockers at each floor, for students to keep their valuables. The University also provides for a brand new girls' hostel with built-in utility and recreation facilities for the students. We at SLS, Pune, just like other sister institutions of SIU, care for our students' health and therefore, have a Symbiosis Centre for Health Care on campus.



CAREER AND PROFESSIONAL DEVELOPMENT CELL

Symbiosis Law School, Pune, as one of the pioneers in the field of legal education in the country, is devoted to the spreading of knowledge, learning and understanding in the service of society. In view of upholding our virtues, we provide opportunities to our students to become trained, groomed, and perceptive professionals who have leadership skills and a broad range of professional skills such as legal services, legislation, law reforms, advisory and advocacy. The Career & Professional Development Cell functions as the primary facilitatory body for the process of professional development and constructive employment for our students. The broad objectives of the cell are campus recruitment, training and development and internship opportunities.



Our students have been placed at top tier law firms such as Cyril Amarchand Mangaldas, Shardul Amarchand Mangaldas, Lakshmikumaran and Sridharan, AZB & Partners, Khaitan & Co, Crawford Bayley & Co etc. The Cell has also successfully placed students in industrial and government sectors ranging from corporate, banking to litigation and as an in-house legal counsel in organization such as GMR, Tata Communications, Vedanta, ICIC Bank, IndusInd, Tech Mahindra and Telecom Regulatory Authority of India (TRAI) etc.

The Cell works throughout the year to implement and execute the processes of Campus Recruitments, Internships, Training and Development, Industry & Alumni Relations and Entrepreneurial development. With years of experience, the cell has developed a wide array of networks ranging from litigation firms, corporate firms, solicitors, private practitioners, to governmental commission and agencies.

With regard to training and development, various initiatives are undertaken on behalf of the cell to hone the skills of the students so that they may be better equipped at the time of their interviews and the impression thus created, guarantees employment. These initiatives include various workshops, mock group discussions interview, training sessions, and guest lectures. These activities prepare them for pre-placement offers, on-campus, and off-campus recruitments.

With regard to internship programmes, the cell provides opportunities to the students to intern in their winter and summer breaks. This provides a better exposure to the students in terms of skill development so that the same can be applied in their recruitment from college or via any other recruitment platform. The cell provides internships based on the preferences of the students and is in constant contact with the respective companies to ensure greater feasibility and accessibility to the students during their internships. Despite of the current pandemic situation, the cell successfully provided students with numerous online internship opportunities so that the professional and learning development of the students is not hampered.

With regard to campus recruitment, each candidate that chooses to be placed via Symbiosis Law School, Pune, undergoes a stringent process of verifying their Curriculum Vitae (CV) to ensure validity in the documents that are provided to the recruiters. This provides assurance that the students go through a screening process via the college itself before the screening process undertaken by recruiters. This applies to the five-year law students, the three-year law students and the students pursuing their master degrees.

The Career & Professional Development Cell has been tirelessly facilitating the professional development of our students and has been successful in attaining the aforementioned goals by providing our students with the best opportunities.

SYMBIOSIS CENTER FOR LEGAL SKILLS

Symbiosis Law School Pune, through its skill centre impart generic career and placement skills training in five verticals where all the final year students of five years (B.A.LL.B. (Hons) and B.B.A.LLB. (Hons), LL. B. programme and LL.M.) students get training to inculcate various skills so as to boost their talent and ability in furtherance to overall academic and professional readiness.

The objective of such skill courses is to cater the academic and professional requirements of our students and enhance their placement and employability in various sectors such as corporate, banking, civil services, public services and other allied branches of profession of law.

This center has successfully launched programme such as 'Legislative Drafting', 'Preparation for Judicial Services Examination: Strategy, Syllabus Components & Examination Techniques', 'Maritime Law and Practice Skills', 'Legal data base and legal research skills' among others

In addition to this centre organises consultation and mentoring sessions for students through professionals, industry experts and Judges of various courts.



INTERNATIONAL CELL

The International Cell at Symbiosis Law School, Pune, enables the students to engage themselves in the activities that envisage the entire globe as one functioning organism. It hosts initiatives that allow the students to broaden their horizons and alter the paradigms of what they perceive of internationalization as a phenomenon. The initiatives of the Cell feature Faculty Exchange Programmes including the Faculty enrichment, Scholar-in-Residence, ICCR Chair and DAAD Passage to India Programmes, Student Mobility Programmes including study visits, delegation visits, summer school, semester exchange and international internships, Area Study Centers and an affiliation with the International Law School Association Chapter.



As a brainchild of the Director, the Cell also facilitates student learning through certificate courses, and faculty training by way of international seminars under the EURASIA project, to deepen the understanding of the interplay between Asian and European legal studies. In pursuit of Internationalisation of legal education, special emphasis is laid on international collaboration, 21st century Teach Skills Project, faculty and student exchange, EU value added courses and FDP Cascading Learning (EURASIA Project).

The International Law Students' Association, Chapter of Symbiosis Law School, Pune facilitates student participation in Juristas (International Law Essay Writing Competition), MUNs (Model United Nations), workshops and guest lectures. The International Cell fuels unique area study centres in European Union Legal Studies and South Asian Legal Studies. This leads to several visits by International faculty and students.

The SBA tirelessly works to inculcate an interest in mooting and allied activities to help students grow into skilled oralists, researchers and drafters. In pursuance of this, the SBA follows a policy of encouraging participation in mooting from all batches. To allow them to compete on an equal footing, the SBA organizes extensive workshops and demonstrations to enable them to learn the process of mooting. Further, the SBA arranges for interactive sessions with experienced mooters and litigators from previous batches to guide the present mooters in a better manner. The SBA also organizes the 'Symbiosis Law School, Pune - Internal Moot Elimination' during the year which puts senior batches against the junior batches and the 'Novice Moot Elimination' to encourage the first years to take up mooting, and subsequently represent the college in numerous moot court, mock trials, judgment writing, client counselling and negotiation competitions.

Students who represent the college in the national and international mooting circuit are trained and assisted by not only the SBA members, but also by experts in various fields of law. Workshops are conducted regularly to help students hone their oratory and presentation skills. Memorials are reviewed and mock pleadings are conducted by both faculty and senior mooters to ensure that every team which represents the college has been given optimum training.

The institution along with the SBA has taken huge strides in providing impetus for the development of the competitions at both national and international levels i.e. Symbiosis Law School, Pune - National ADR Tournament and Symbiosis Law School, Pune - International Criminal Trial Advocacy Competition.

The zeal which students have towards mooting and the support offered by our faculty are reflected in our results. In the past, our students have represented and won laurels in prestigious competitions such as 25th Annual Stetson International Environmental Moot Court Competition 2021, Oxford Price Media Moot Court Competition 2020-21, 18th Willem C. Vis East International Commercial Arbitration Moot - Hong Kong, Philip C. Jessup International Law Moot Court Competition 2021, 6th NLIU Justice R.K. Tankha Memorial International Arbitration Moot 2021, 12th NLU Antitrust Law Moot Court Competition 2021, 9th RGNUL National Moot Court Competition 2021, GNLU Moot on Securities and Investment Law 2021 and CPR International Mediation Competition 2021.



ALUMNI COMMITTEE AND CELL
