FROM THE EDITORIAL DESK

The Farmers Empowerment and Protection Agreement on Price Assurance and Farm Services Bill, 2020 seeks to form a national framework for farming agreements to protect farmers in dealing with middlemen. Contract farming stands to be the primary focus of the bill. The bill also aspires for a fair and transparent manner of dealings between parties on both ends.

Under this bill, the farmer would have a predetermined agreement with buyers or sponsors, prior to the sowing season, while the government would act as an intermediary. The scope of sponsors has been widened to individuals, partnership firms, companies, limited liability groups and societies. The agreement so formed between the producer and the sponsor could include mutually agreed terms relating to the supply, price, quality, standards and farm services. Furthermore, the purchase price which covers under its ambit the methods of determining the price can also be added to the agreement. To counter price fluctuation, the bill makes provisions for a clause to be added which fixes a guaranteed price that the sponsor would be liable to pay. Additionally, the bill also provides for a mention of the bonus and incentives that a producer would possibly stand to gain. However, despite all the seemingly hopeful provisions, the bill fails to cover even a single mention of the Minimum Support Price (MSP).

The contentions that various policy makers and citizens of the country have with the farm bills primarily stem from the contents of the bill and secondarily from the manner in which they were passed by the parliament. The Farmers Empowerment and Protection Agreement on Price Assurance and Farm Services Bill, 2020 requires a close scrutiny. India's farmers have not experienced any watershed development in their condition since independence. Even today, although farming employs 46% of the country's workforce, less than 20% of India's GDP is credited to farmers. The little relief that farmers received of price assurance was because of the provision of Minimum Support Prices with regard to various staple commodities. With the introduction of this bill, the parliament has remained silent on the issue of Minimum Support Prices.

The deliberate exclusion of the same created a trust deficit between the farmers and the government. In a country where agriculture is the backbone of the economy, a deteriorating relationship between the producers and lawmakers is a harbinger of instability. Furthermore, the deregulation of agriculture in India and the inclusion of private players places the farmers in a vulnerable position. Armed with the bargaining power and supplemented with better access to legal recourse, wealthier and more powerful private players could directly threaten the position of small and marginal farmers.

The major fear that farmers harbour is that they would be bound by unfavourable contracts and will be rendered helpless while fighting any legal battle against sponsors.

Currently, APMCs act as regulating bodies between the farmer and any private buyer. The bill might seek to gradually phase out APMCs from the agriculture ecosystem. This would lead to the loss of employment for APMC workers across the country and would lead to severe revenue loss as the fees levied on transactions in APMCs would not be collected. The second contention with the bill is the manner in which it was passed by the parliament. While coursing through the hurdles and hardships posed due to COVID-19, the plight of farmers was compounded with the controversial bill being passed by a voice vote despite the request from the opposition for a recorded vote. The fateful day also witnessed Rajya Sabha TV muting the audio telecast of the proceedings when the opposition's MPs were protesting.

This stubborn stance taken by the government to refuse to discuss the bill and allow for a recorded vote when coupled with the unceremonious crude majority by a mere show of hands and voices reflects poorly on the democratic ideals of this country. Law-making has and will remain a deliberative and consultative process in any democracy. The rash decision taken by the NDA government to skirt around the referral of the bill to standing committees for scrutiny and examination weakens the reliability of these bills.

In light of the circumstances in which the bill was passed as well as the surrounding criticism, a close look into the bill is warranted to rightfully determine the intentions of the government behind this bill.


The conference received 64 abstracts and finally witnessed the paper presentations of the selected 36 including 4 by foreign scholars.


Participated in NEBULA 2021- Battles of E-Cells

Out of the many participants the top 11 participants got an opportunity to perform at Pani Parishad and were felicitated with the Jalmitra Award.








Essential Commodities Donation Drive
