## From the Editorial Desk

"It is not the strongest of the species that survives, nor the most intelligent, but the one more responsive to change." -Charles Darwin

If there is one word that defines the 21st century, it has to be "adaptivity". The world led by the forces of globalization and digitisation is evolving at an incredibly fast pace. While globalisation has led to connectivity beyond physical boundaries, it is digitisation that has enabled this connectivity. These forces though have led to an increase in our collective competencies and economic opportunities but has led to more complexities and ambiguities. To be able to adapt to these rapidly changing times we must acquire the skills necessary to survive in a highly evolving world.

The 21st-century skills are the new building blocks for learning in today's world. They are universally applicable tools for improving ways of thinking, learning and working. Critical thinking, creativity, problem-solving, metacognition, collaboration, communication, and global citizenship are some of the important skills. In today's fast-paced world, literacy is no longer limited to one's ability to read and comprehend but encompasses skills that make them 21st-century ready. The integration of technology with our society has overturned the globe, technology is seen as the harbinger of the fourth industrial revolution. The growing reliance on technology has had its impact on the job market too, employers now seek candidates who show a higher "Digital Quotient."

This makes the case for Digital Literacy. As per UNESCO (2013), digital literacy can be viewed as an umbrella term that encompasses a range of meanings. It includes ability to use digital devices or software, to consume and produce digital content, and to participate in digital communities. The simple fact is that digital literacy is now required for living, learning, and working successfully.

Digital Literacy is no longer a luxury that is meant for only a few but a right that should be seen as an extension of the Right to Education which is a basic human right. In 2016, UNHRC articulated access to the internet as an essential human right. The Supreme Court in Anuradha Bhasin v Union of India (2020) recognised the Right to the Internet as a fundamental right. This expansion ensures that the constitutional provision are in tune with the technological innovation. Millions of Indian citizens rely on the internet as their primary source

III Year of information. The Hon'ble High Court of Kerala in Faheema Shirin RK v. State of Kerala (2019) case held that the Right to the Internet is a part of the Right to Education and Right to Privacy under Article 21A and Article 21 of the Constitution of India respectively. Internet access not only enhances the opportunities of students to acquire knowledge but also enhances the quality of education.

This comes at a time when the COVID-19 pandemic forced all of us into the virtual world and the need for digital literacy is being felt more than ever. But it raises a more pertinent question that whether Indians are skilled enough for the 21stcentury world? As per National Sample Survey 2017-18, only about 38 per cent of India fits the definition of being digitally literate. Further, there is a rural-urban divide in terms of digital skills where 61 per cent of the urban population is digitally skilled as against 25 per cent of the rural population. While India is undergoing a digital revolution that has the potential to propel us forward in terms of economic growth and development, we also risk creating a new class of digitally-illiterate citizens. Digital Poverty is a new concept of poverty that refers to the inability to access and benefit from information and communications technology services due to a lack of access to the internet.

In terms of digital literacy, the government has made efforts to improve citizens' digital literacy skills. The National Digital Literacy Mission, the Digital Saksharta Abhiyan, and the Pradhan Mantri Gramin Digital Saksharta Abhiyan are the three main digital literacy programmes that are in the process of implementation. However, these schemes suffer from basic implementation problems due to lack of digital infrastructure and digital penetration. As a result of which there is a wide urban digital gap.

Thus, the need of the hour is to reassess the measures taken and include a more long-term perspective. Long-term initiatives can include the integration of digital literacy programmes with educational curriculums and general literacy programmes. Digital courses can be introduced at a more primary level as also envisioned by the New Education Policy, 2020. Concerning the lack of internet services, global experimentation indicates that success in promoting digital access for remote communities via satellite broadband connectivity should be prioritised. Many start-ups and ventures have also been building in the same context, which includes providing courses at subsidised rates, making connectivity easier, thus a PPP policy can be worked out that ensures that the infrastructure can be provided by the private sector players while implementation is carried out by public authorities.

Thus, it is high time that the government, policy-makers, legislators and civil society push for the integration of digital skills in our existing educational frameworks so that the country doesn't miss out on the economic and social opportunities that this century has to offer.





## SLS-P delegation to the Lok Sabha





Dr Shashikala Gurpur was invited to give the welcome address. Justice Ambadas H Joshi, Lokayukta, expressed the need to take up the issue of non-inclusion of the LGBTQIA+ community in an affirmative manner. Covering larger aspects of inclusion, Justice Joshi also mentioned that the onus lay upon institutions in the country to groom the community to make people believe in equality for all. Dr. Pragati Singh, clarified the difference between 'inclusion'








# CELL ACTIVITIES

# 1.Intra-College Workshop on Practical Aspects of the Functioning of Capital Markets

Symbiosis Law School Pune's Corporate Law Cell, in collaboration with the Career and Professional Development Cell and LawEcon Cell, hosted a two-day workshop on "Practical Aspects of the Functioning of Capital Markets" on Tuesday, October 12th, and Wednesday, October 13th, 2021. The resource person was Mr. CS. Jayavant Bhave, the proprietor of "J B BHAVE & CO. Company Secretaries," a reputed firm of Pune. All the students found the workshop to be a great learning experience.

Starting with the fundamental notion of equity and debt capital, which is the foundation for forming Capital Markets, Sir covered different regulations related to public offerings such as IPOs, FPOs, eligibility norms, prospectuses, IPO grading, book building, depositary receipts, and so on. Overall, the workshop was a resounding hit in achieving its goal of providing valuable knowledge to students. Everyone gave positive feedback, demonstrating the workshop's success.



## 2. Intra-Cell Group Discussion on "Regulation of Digital Currencies by the Banks: A Need to Prevent the Bank's Bankruptcy"

A very fruitful group discussion was conducted by the LawEcon Cell for the academic session 2021-22. It was held on 27th November 2021, and witnessed the cell members enthusiastically participating in the discussion over "Regulation of Digital Currencies by the Banks: A Need to Prevent the Bank's Bankruptcy". The event was held via Google Meet, owing to the COVID-19 pandemic, and all the members of the Cell, both newly inducted and previous members, had a penchant for tackling the menace of the misuse of cryptocurrency and indicated its positive notions as an instantaneous means of exchange, beyond the trajectory of borders. The members also discussed how the blockchain technology, used for mining cryptocurrency, is a grave cause of concern for the environment, thereby necessitating the discovery of an alternate method. Towards the end, the members agreed that there was a need for reserve-backed digital currencies so as to regulate the digital currencies.

The committee insisted on creating awareness towards the cause of animal liberation from the dire circumstances the animals are subject to, due to the human made menace of plastic pollution.




# CAREER AND PROFESSIONAL DEVELOPMENT CELL

The Career & Professional Development Cell functions as the primary facilitatory body for the process of professional development and constructive employment for our students. As a part of its training and development activities, the CPD Cell organized the Mock Group Discussion and Personal Interview Process (Mock GD-PI) for final year students to equip them with the requisite skill, professionalism, and etiquettes for a seamless recruitment process. The Mock GD-PI process is instrumental in grooming students for actual recruitment processes and helps them tackle their strengths and weaknesses.

The cell facilitated in providing 253 students with internship opportunities, out of which, 162 students secured opportunities in law firms such as AZB & Partners, Khaitan &

Co, Argus Partners, etc; 81 students secured internships with various NGOs, 8 internships in multiple corporate houses and 1 internship in a prominent media house.

Since the beginning of this academic year, 50 students were recruited by the above-mentioned firms as well as firms such as ICICI Bank, TATA, Wipro, etc. and this number continues to increase with every opportunity. With several recruitment drives still in process, the number of students placed continues to increase. The Cell facilitated in providing 240 recruitment/job opportunities to final year batches of the 5year and 3-year programme, LLM students and alumni. In addition, 15 students secured assessment internship opportunities with established firms like Spice Route Legal and BMR Legal, among others.




gain valuable insights about the biodiversity in the jungles of the national park as well as its history and management.

#### Symtaaron ki Shaam: 12th to 19th November, 2021.






# **ALUMNI CELL**
