#### FROM THE EDITORIAL DESK

The year 2020 witnessed the barriers posed by the pandemic in the form of lockdown orders, social distancing coupled with spiralling health concerns, and skyrocketing anxiety among everyone.

Schools and universities were abruptly closed and students across the world struggled to get back to their homes. Despite these challenges, the education sector emerged as a warrior and stood against all odds, to uphold their goal of imparting knowledge. Amidst the struggle of determining methods of learning beyond the physical boundaries of the classroom, students and teachers found themselves at a juncture where there was a need for paradigm shift in the channels of learning and education.




A Panel Discussion cum Public Consultation on 'Transformation of Criminal Justice System in India' was held by Symbiosis Law School, Pune on 19 October 2020.

With the aim of reforming the Indian Criminal Law framework and Justice System, the Ministry of Home Affairs, Government of India invited SLS-P, to engage in research cum public consultation to review the criminal laws of the country and bring forth the necessary recommendations by engaging the public. The relevant literature and data collected from more than 120 stakeholders including Judges, Lawyers, Academicians, Police, third gender, psychologists, researchers, experts, forensic officers etc. in order to understand the gaps of the Criminal Legal Justice System.

The Welcome Address was delivered by Dr. Shashikala Gurpur and then the panel discussion began. Each panel first discussed the recommendations derived by the SLS-P team from their extensive research, following which polling for the recommendations was opened. The panels consisted of various luminaries such as Special Public Prosecutor Adv.Ujjwal Nikam, Mr. Rohit Athavale, Journalist with Maharashtra Times, Mr. Alok Agarwal, Research and Policy Advisor of NALSA, amongst others.

Over the course of six panel discussions, expansive topics ranging from witness protection, coordination between police and public prosecutors, reforms in the prison system and more nuanced and relevant areas of law were discussed.

Nearly a hundred recommendations were discussed by the panels. A comprehensive set of recommendations was finally agreed upon by the panels and the same was sent to the Ministry of Home Affairs, Government of India by October 28, 2020.




#### LAW HAWKS FORUM




#### **ROTARACT CLUB**


