

## FROM THE EDITORIAL DESK

Being a nation of billions, religion acts both as a source of unity and division in India. Right to practice one's own religion of choice has been rightly accorded the distinction of a fundamental right by the Constitution and an integral aspect of this privilege is one's right to worship. Unfortunately, for years, the Indian society has struggled to make this right a universal one. There is demarcation of several places of worship on the basis of one's caste, gender or faith. Hinduism is scattered with examples of blatant practices such as restricting entry of women at the time of their menstrual flow or the barring of entry of people belonging to a lower caste to any certain temple. A similar pattern is visible in Islam where Muslim women, as per the words of prophet Muhammad, are instructed to pray from home rather than from inside a mosque.

Today, society is in a state of flux, where any form of inequality that exists between two distinctive groups is brought under the microscope of reasonableness. Justice is a mirror of the society and the institutions of justice have served the nation in protecting and upholding the rights enshrined in the Constitution. The recent judgment by the Honourable Supreme Court on the issue of allowing the entry of women inside the Sabarimala temple in Kerala, brings out several important legal questions. The primary rationale of the court was based on the fact that men and women have equal status and any form of restriction of the movement of women inside the temple tampered with their fundamental rights. Remarkably, there are several temples like the Lord Brahma temple in Pushkar, Rajasthan, where married men are barred from entering. Therefore, the ratio must benefit male and female alike and similar pleas must not remain unheard.

If the philosophy of the court is to advocate equality amongst all the members of a religious community, it must expand its umbrella to issues beyond the gender of a person. For instance, in the famous Jagannath Temple in Puri, Odisha, lower caste Hindus are not allowed to enter based on centuries of practice. Similarly, right to worship does not prohibit a particular individual to limit their choice of worshipping to only one religion. The restriction of movement in the form of barring of entry of non-Parsis is in a Parsi fire

temples, disallowance of Non-Hindus inside the aforementioned Jagannath Temple and the denying of non-Muslims to pray at mosques, raises a huge question - whether a citizen of India is allowed to pray at any religious institution regardless of one's religion? Another interesting point arises when there exist 'unreasonable qualifications' for the post of priest across all major religions. This leads to a dilemma whether the law should, at all costs, implement the sacrosanct values of the Constitution, overlooking the fact that it is a religious issue and the court should not interfere in religious practices.

The contrary argument of the aforementioned statement was repeated by Honourable Justice Indu Malhotra, the sole dissenting judge in the Sabarimala judgment, where she stated that the Court must remain cautious in dealing with matters of religion since it is setting a precedent that it has the right to alter the functionality of a religion based on its interpretation of the Constitution. Albeit correct, it is also vital to remember that change is the inevitable truth. Hence, right to practice religion must be allowed to all without any fetters ensuring that any form of exclusion be legally justified.
