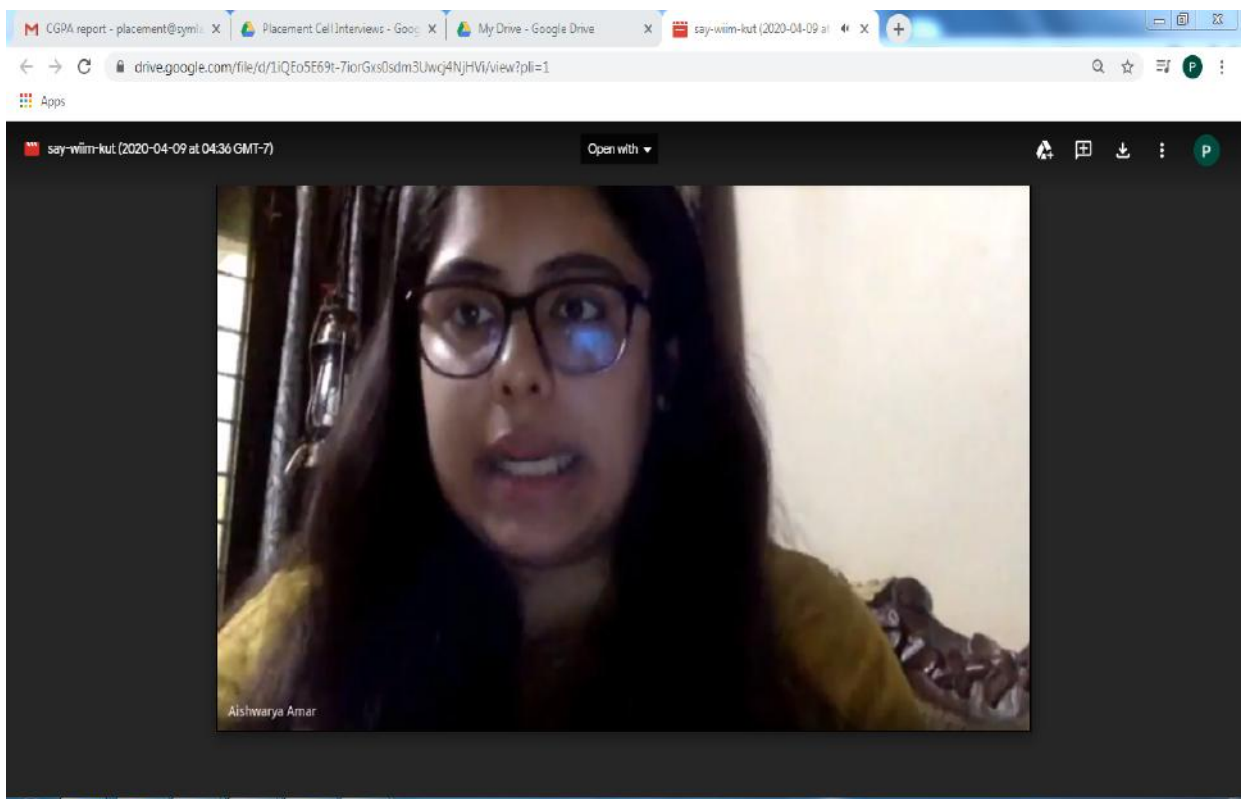
Date:-9th April 2020

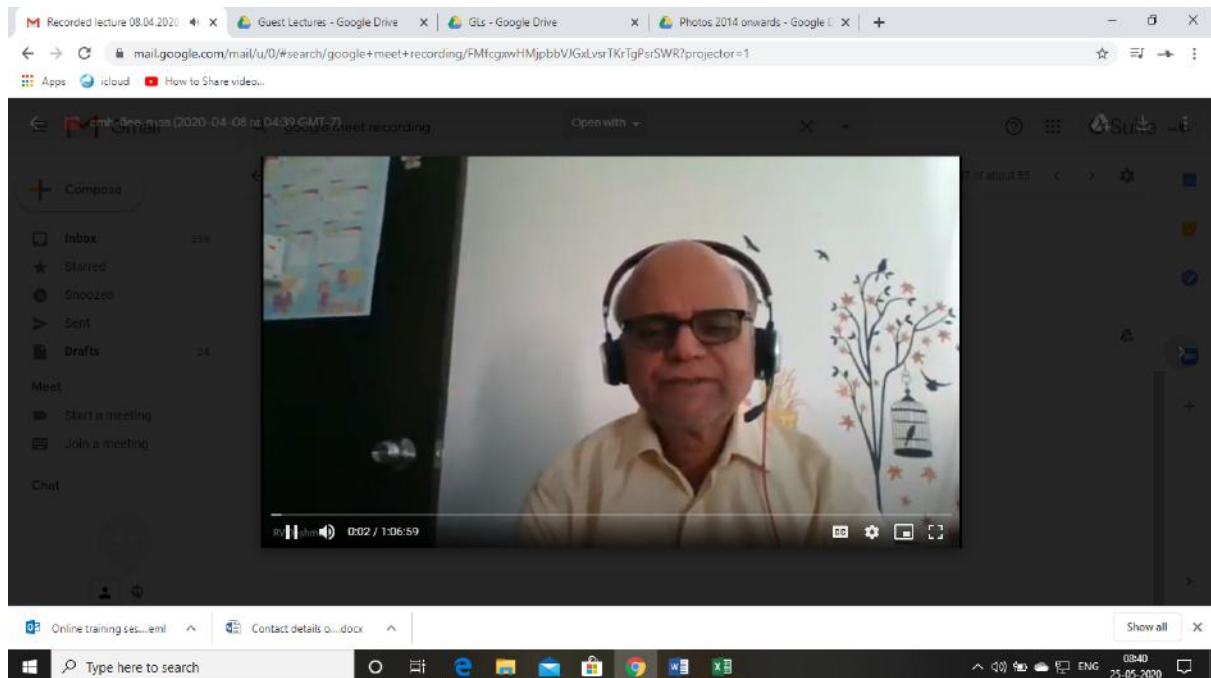
Date:-9th April 2020

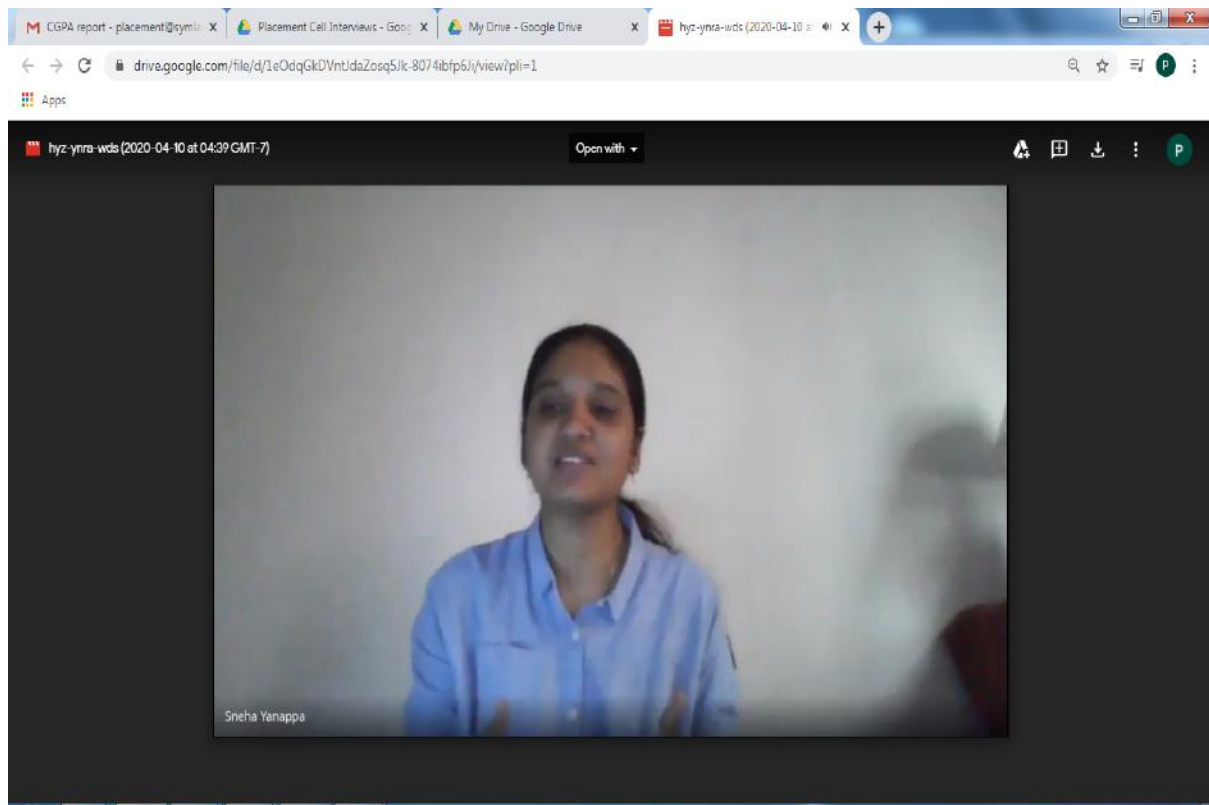
Date:-10th April 2020

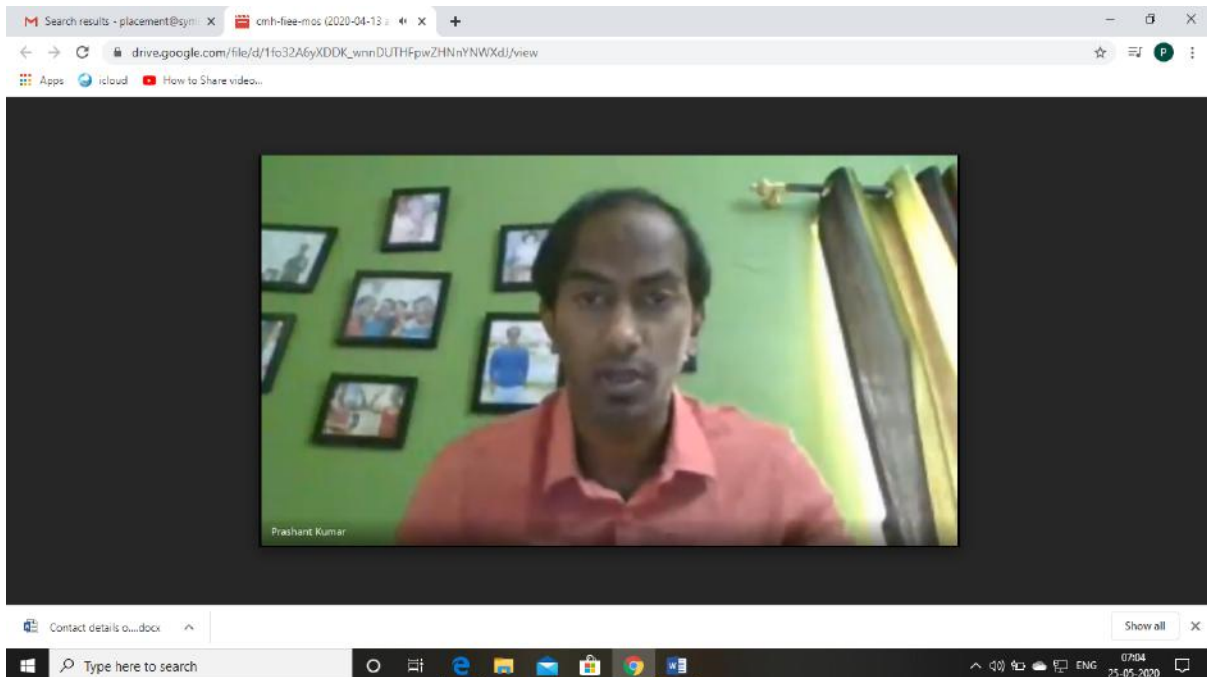
Date:-11 and 13th April 2020
