Students who are pursuing programs, other than the law program and desiring to seek admission to the diploma program in law need to be graduate from any statutory University and fulfill other eligibility criteria prescribed by the Symbiosis International University.

11. **EXAMINATION & METHOD OF ASSESSMENT** : The examination will be conducted at the end of the year. Each theory paper will consist of 125 marks which will be divided into internal (40%) and external marks (60%) and Practical Paper will consist of 125 marks which will be completely internal.
12. **STANDARD OF PASSING** : To pass an examination for diploma program a candidate has to obtain 40% marks in each head of passing. For those who claim exemption based on Diploma, marks will be converted to CGPA.
