Programme Structure 2015-16

1. **OBJECTIVE** : This diploma programme provides the opportunity for candidates to receive advanced instructions in the relationship and interplay between existing labours related legislation and changing industrial scenario. The diploma is especially designed to meet the needs of those whose prior education has been in the field other than law and who would like to supplement their database with in-depth knowledge of labour laws.
2. **DURATION** : One Academic Year
3. **INTAKE** : 80 seats
4. **RESERVATION OF SEATS** : Not Applicable
5. **ELIGIBILITY** : A student who has passed 12th standard examination of recognized board and is pursuing 5-year law program in any law college in Pune is eligible for admission to the diploma programs conducted by Symbiosis Law School in any year. Students who are pursuing programs, other than the law program and desiring to seek admission to the diploma program in law need to be graduate from any statutory University and fulfill other eligibility criteria prescribed by the Symbiosis International University.
6. **SELECTION PROCEDURE** : First come First serve basis
7. **MEDIUM OF INSTRUCTION** : English
8. **PROGRAMME PATTERN** : Semester Pattern – 2 Semesters

11. **EXAMINATION & METHOD OF ASSESSMENT** : The examination will be conducted at the end of the year. Each theory paper will consist of 125 marks which will be divided into internal (40%) and external marks (60%) and Practical Paper will consist of 125 marks which will be completely internal.
12. **STANDARD OF PASSING** : To pass an examination for diploma program a candidate has to obtain 40% marks in each head of passing. For those who claim exemption based on Diploma, marks will be converted to CGPA.

13. **AWARD OF DIPLOMA** : The Diploma will be awarded at the end of the programme by taking into consideration the performance of the term end examination.
